#### **Organization**

The Leonard E. Burket Christian School is a ministry of the Assembly of God of Center Moriches. The school is recognized by New York State as a non-public school providing a program of instruction equivalent to that offered in public school. Our high school is registered with the New York State Department of Education and we are authorized to issue Regents Diplomas.

The church council of the Assembly of God serves as the school board.

#### Curriculum

The academic program at LEBCS for Kindergarten through Grade 6 is based primarily on the *A Beka* curriculum of the Pensacola Christian School in Pensacola, Florida. In the upper grades students work independently completing a variety of online courses.

Students at all levels receive instruction in Bible, English Language Arts, Reading and Literature, Mathematics, Science, Social Studies, Handwriting, and Second Language. In addition students attend classes in Art, Music and Physical Education.

#### Admission

All first time students are admitted to LEBCS on a ten-week probationary basis. Parents must fully support the policies and programs of the school to insure a successful enrollment. Students and parents must apply for admission in person.

To apply, parents must fill out a registration form and submit it with the registration fee, an up-to-date immunization record, a physical examination report signed by the student's physician, a copy of the student's birth certificate, and a transcript release form (if the student is transferring from another school).

#### Financial Information

Every student who enrolls is charged an annual *registration fee* that is nonrefundable. This fee includes a one-time accident insurance fee. There is also an annual *Book and Supply Fee* that is non-refundable once the school year begins. The *Book and Supply Fee* covers a number of items including, but not limited to:

Textbooks and Curriculum for Students and Teachers Instructional Books, Equipment and Software Art Supplies – P.E. Equipment and Supplies Music, Musical Instruments, Sound Equipment and Supplies School Office and Teachers Supplies and Materials Copier Equipment and Supplies Classroom Equipment and Supplies – e.g. laptops and TVs, markers/chalk, erasers, clocks, desks, chairs, tables, toys, etc. Science Equipment and Supplies – microscopes, chemicals, safety equipment, etc.

Tuition and applicable late fees are collected by the school office. In order for students to begin school in September all past due tuition, as well as the Registration Fee, the Book and Supply Fee, and the first month's tuition must be paid. Checks are made out to "LEBCS." A 5% discount is applied to tuition paid in full before September 1<sup>st</sup>.

It is the responsibility of parents to see that tuition is paid on time, or to notify the school office and make alternate arrangements if a payment is going to be late. Tuition is due the first of each month. If it is not paid on time there will be a late fee added. If the tuition is not paid by the last day of the month, parents will be asked to remove their children from school for the following month. There will also be a bank fee charged for any checks returned for insufficient funds.

Families enrolling more than one child will receive tuition discounts as follows:

1 <sup>st</sup> Student	<b>Full Tuition</b>

Tuition assistance applications are available through the school office. They are considered on a case-by-case basis. Tuition assistance is not usually given the first year a student is enrolled at LEBCS.

Students transferring from other private schools will only be admitted if their account is paid in full at their previous school. Students enrolled at LEBCS will only be allowed to re-register for the next school year if their account at LEBCS is paid in full. End of the year report cards will not be released until all tuition and fees from that school year are paid in full.

Any monetary gifts given to LEBCS are tax-deductible.

During the school year students will be asked to participate in fund-raising projects. Participation is voluntary, but the accounts of students who do not participate will be charged a one-time fee of \$100.

#### **Daily Schedule**

Kindergarten – Grade 6	9:00 am – 3:00 pm
Grades $7 - 12$	9:00 am – 3:00 pm

All full-day students will be given a lunch period. Students may bring their own

lunch and drink or purchase lunch each week. Students will not have access to a refrigerator or microwave oven. Snacks are sold at lunchtime for a small fee. Recess follows lunch for all students in Grades K-12, and will be outdoors (weather permitting).

Chapel will be once a week. Parents are always welcome to attend.

#### **Bus Transportation**

Bus transportation is provided by the local school district in which a student resides. Requests for bus transportation must be submitted directly to the school district. The district will determine all routes and schedules. Any questions or problems in these matters should be directed to the district office.

Please note that it is illegal to pass a school bus in the church parking lot or driveway if its red flashers are on. All school buses are equipped with cameras and fines for violators can be quite high.

It is also illegal in New York State to be talking on a hand-held cell phone while driving, so please do not enter the church parking lot or driveway while talking on a cell phone.

All students must leave school on their regularly assigned school bus, or with their custodial parent or guardian, unless that parent or guardian sends a note or calls the school office informing us of any change in plans. Students will not be permitted to call home during the school day to make alternate after-school plans. If parents or guardians comes to pick up students before the regular dismissal time, they must first go to the school office in the back building and sign out those students.

#### Absences/Illnesses/Medication

If a student is going to be absent, parents should notify the school office at 631-878-1727. On the day they return to school, students must bring a written note that includes the reason for the absence and the date of the absence. Our registration with New York State requires us to have a Comprehensive Attendance Policy in place. That policy states that if a student accumulates 10 unexcused absences or 20 excused absences in any one quarter, they will be dropped from their 7<sup>th</sup>-12<sup>th</sup> grade courses and/or be required to repeat their elementary grade level.

If a student becomes sick at school, a parent, guardian or emergency contact will be called to come and pick the student up. *It is extremely important that all families provide the school with the names and numbers of people who are available to come to the school during the day to pick up students in these kinds of situations.* 

Students are never permitted to have or to self-administer prescription or nonprescription medicine during the school day (e.g. cough drops, pain medication). Any prescription or non-prescription medication required by a student during the school day must be dropped off in the school office by a parent or guardian in clearly marked original containers with the student's name and instructions for dispensing printed on the container. In addition, the school office requires written doctor's orders regarding the type, amount, and schedule of medication to be dispensed. A parent or guardian must also sign a medical waiver that will be kept on file in the student's permanent record. This medical form is available through the school office.

Medication will be dispensed privately and discreetly by a school nurse or designated school administrator in the absence of a nurse. Students must be able to tell what medication they are taking, how much they take, and why they take it. Medication will be ingested or administered in the presence of the nurse or administrator and noted on a log in the school office.

Teachers will not dispense medication to any student at any time.

<u>Exception</u>: High school students are permitted to have and to use portable asthma inhalers provided the school office has a completed medical form from the student's doctor on file along with written permission from the student's parent or guardian. If it is determined that a student is abusing the use of an inhaler this permission may be rescinded.

#### Accidents

Students at LEBCS will not be left unattended at any time. In the event a student is hurt or has an accident, the teacher or aide present at the time will gather as much information as possible and fill out an accident report. The school office will contact parents so that they can decide if they want to come and pick up their child. Their decision will be noted on the accident report form. Parents will be notified of any accident in writing or by phone that same day.

In the event a student is unconscious or bleeding profusely as the result of an accident, an ambulance will be called and, if necessary a school staff member will accompany the injured child to the emergency room.

Registration fees cover the cost of participation in an accident insurance policy, which provides supplementary coverage beyond personal health insurance. Application forms and contact information are available through the school office.

#### *Communication*

It is the intention of the faculty and staff at LEBCS to foster open and informal communication at all levels, and to speak the truth in love (Ephesians 4:15). At the same time we want to maintain a sense of orderliness and security during the school day.

All parents and visitors must report to the school office (in the back building) when they come to the school. If a parent calls during the day to speak to a teacher, a

message will be taken by the school office and delivered to the teacher so they can return calls before the end of the school day.

Teachers will keep parents informed of their child's progress during the school year by sending home graded tests to be signed and returned, writing comments on report cards, and scheduling parent-teacher conferences. Parents are also encouraged to download and use the Remind app for receiving messages from teachers and the school office.

#### Discipline

A clear set of school and classroom rules designed to encourage order and responsible Christian behavior will be reviewed the first week of school and posted in each classroom. This will include topics such as raising your hand to ask or answer a question, walking quietly through the halls, remaining in your seat, respecting the person and property of others, etc. When it is necessary to correct a student, teachers will do so in a controlled but firm way, and discipline will be administered consistently and in fairness and kindness.

Initially, most disciplinary action will be administered by classroom teachers (loss of recess or special privileges, in-school detention, etc.) and parents will be informed of such action. For students who continue to misbehave, there will be a conference with the student and his or her parents. Any student who continues to misbehave after these measures are taken will be on probation and may be dismissed from LEBCS.

Students hitting or fighting, using obscene language, or involved in the intentional destruction of property will be immediately suspended from school for at least one day. Students who provoke such behavior may also be suspended. Both in and out of school, students should abstain from speech, behavior and undesirable practices that are in violation of God's Word.

Students will respect the position and authority of all teachers, administrators, aides and other staff members, and treat them courteously, respectfully, and obediently. In grades 7 to 12 students who are sent out of class after repeated warnings to behave will be suspended for one day.

All students will refrain from public displays of affection while in school and conduct themselves in a discreet and Christian manner – no hugging, holding hands, kissing, etc. At school the policy is "hands off."

At no time will any of the school staff administer corporal punishment.

#### Weapons Policy

Students found in possession of a weapon or any item that can be construed as a weapon, or who threaten other students or staff members with violence, either verbally, in

writing, or through some other means (e.g. online, social media, text message, etc.) will be subject to severe disciplinary action including suspension from school for an indefinite period of time. A police report may also be filed.

Within one week of suspension, the school board will determine under what circumstances, if any, the student may be readmitted to school, and what steps must be taken to facilitate readmission. Parents will be responsible for home instruction during that time using material provided by the student's teacher.

Students should also not bring items like water pistols, lighters, matches or laser pointers to school

#### Student Driving

Students may drive to school and park their cars in the school parking lot under the following conditions:

- 1. They must provide the school office with a copy of their class D license (required in Suffolk County), a copy of the registration for the vehicle they will be driving, and a copy of the vehicle's up to date NYS Insurance Identification Card.
- 2. In addition the student must provide written parental permission to drive to and from school and must not transport any passengers to or from school including siblings attending LEBCS.
- 3. The student must park in appropriately designated areas.
- 4. Students are not permitted to drive themselves or others passengers to school sponsored field trips.

Driving to and from school and using the school parking lot is a privilege and may be withdrawn at any time at the sole discretion of the school administration.

#### Homework

All students will receive homework appropriate for their grade level. Homework assignments must be completed and returned, and will figure into a student's report card grades. Parents should monitor homework and assist by listening to children read, giving them practice-spelling tests, and drilling them in study material. *Parents should not do homework for their children*.

In addition students will always be expected to do their own work on all assignments unless a teacher has granted the privilege of students working together or collaborating on a project. In writing assignments students should avoid all forms of plagiarism, i.e. using another writer's ideas or words without giving credit for them.

If a homework assignment cannot be completed due to unusual circumstances, parents should send in a note explaining the problem. Please be advised that incomplete assignments (for whatever the reason) will affect a student's grade.

#### Conferences

Parent-teacher conferences are scheduled after the first grading period. All parents should do their best to attend. Conference times will be adjusted to accommodate as many as possible. Parents who would like to meet with their child's teacher at any other time during the year should feel free to call and make an appointment.

#### **Report Cards/Grading Policy**

Report cards will be sent home each quarter and will include comments from the student's teacher reflecting the student's ability or lack of ability in specific areas.

Letter grades will be given as follows:

Students who fail up to two subjects will be required to attend summer school and receive a passing grade in those subjects before being promoted. Students who fail more than two subjects will be retained – if they are permitted to return to LEBCS. Summer school or private tutoring is recommended for students who pass but show a definite weakness is some subject area.

#### Dress Code

Students are expected to dress *modestly*, *decently*, and *appropriately* (1 Timothy 2:9). All students in grades K - 12 must dress as follows:

- 1. All clothing must be clean and in good repair (no holes, no frayed hems).
- 2. Shorts must be no shorter than knee length.
- 3. Shirts must be loose fitting and long enough to cover the waistband of the student's pants or skirt no bare midriffs.
- 4. Girls' skirts or dresses must be no shorter than knee length with no slits, and they must be loose fitting.
- 5. All pants, shorts, capris, and skirts must be worn up around the waist (no low rise or low riding pants, shorts, or skirts).
- 6. Students may wear fleeces, sweaters, or sweatshirts indoors but they may not have their hoods up.
- 7. No hats or bandanas may be worn inside.
- 8. No flip-flops or sandals unless they have an ankle strap that secures the sandal to their foot.
- 9. No pajamas.

- 10. No piercings (other than girls' earrings) and no visible tattoos.
- 11. Please note that students are always welcome to dress "higher" than this standard (e.g. dresses, shirts and ties, etc.).

#### Music/Videos/Cell Phones/Computers

Students are not permitted to bring portable electronic devices to school, and they are not permitted to exchange music, videos, or video games during the school day, physically or digitally. Magazines and periodicals allowed in school are limited to those being used for class purposes (no entertainment magazines). If students bring any of these items to school, the items will be confiscated and parents will be asked to come to the school to retrieve them.

During the school day, students are not permitted to have or to use cell phones. If a student must bring a cell phone to school, the phone must be turned off and left in the student's backpack or locker. The first time a student is found with a phone at any time during the school day, that phone will be confiscated and returned at the end of the day. The second time, a parent will have to come to school to pick it up.

Students are not permitted to send or retrieve e-mail, engage in instant messaging or chat sessions, or post to social media sites on any devices during the school day. The online activity of older students will always be monitored by a teacher or aide. Though we do have filters and controls in place, students viewing inappropriate material or violating the policy regarding e-mail will be subject to discipline. Students in grades 5 to 12 are permitted to bring their own laptops or tablets to school, but may only use them to complete online course work.

We also expect that communication between LEBCS students when they are away from school will be appropriate and pleasing to the Lord. Students are not permitted to bully, threaten, or harass other students with impunity simply because they are doing it after school or from home. We will take action against any student who is sending inappropriate online messages or text messages to other LEBCS students if those students or their parents inform us of the offending communication and are able to verify it. We will also take action if students are posting objectionable material on line – including text or images.

#### Field Trips

All classes may participate in field trips during the school year that are educationally valuable. These field trips take place during the normal school day. No student will be allowed on a trip without a signed permission slip.

All volunteer drivers (including those who are only driving their own children) must complete a Volunteer Driver Application Form and have it on file in our school office along with a copy of their license and current declarations page from their auto insurance policy.

All school rules apply on all field trips and on all school-sponsored events on the school's premises and away from it.

#### **Emergency School Closing**

When school will be closed, have a delayed opening, or be dismissed early due to inclement weather, an announcement will be made on radio station WALK -97.5 FM, <u>www.walkradio.com</u> - Storm Center, and on News 12. Parents will also receive a notice on the Remind app. Parents are encouraged to check these various outlets on any day when weather conditions may warrant a school closing.

In the event of an early dismissal, the school office will try to contact the parents or emergency contact individuals listed for Kindergarten and 1<sup>st</sup> Grade students before releasing them on the bus.
